All Universities and Colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled, or substantially financed directly or indirectly by funds provided by the Government shall come within the meaning of a Public Authority under this Act.

The primary object of the right to information act is to empower the citizens, promote transparency and accountability in the working of the Government, contain corruption, and make our democracy work for the people in an absolute sense. The Act is a big step toward informing the citizens about the Government's activities. An informed citizen is better equipped to keep necessary vigil on the governance instruments and make the Government more accountable to the governed.
